# **USE OF SPACE**

- You agree to leave the studio in the same condition as received. If any item belonging to Dance To The Rhythm Studio is damaged or lost, please report to staff to assess the damage or situation. Renter will be responsible for the repair or replacement if deemed necessary.
- 3. If any damage to the studio is made, please report it to the staff. Renter will be responsible for the repair and replacement if deemed necessary.
- 4. No flammables or weapons can be used or brought in to the studio that may cause damage or harm to humans and the property.
- 5. Extended hours will incur extra charges at \$70 per hour for Studio B and \$120 per hour for Studio A. Extended use of the Studio is subject to approval of the management for the use of the studio beyond the event time.

#### **PAYMENT**

- 1. Deposit of 50% is required to book the Studio.
- 2. Full payment of the rental balance **must be paid 2 weeks** before the event.
